I guarantee the recipient of the donation, for the transfer of ownership of 50% of the capital of the company, object of this contract, to be free from any kind of obligation to third parties.

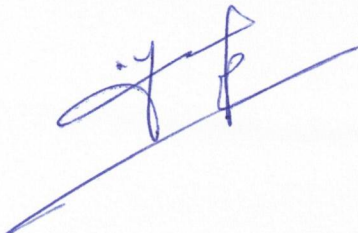
